## DELANO FAMILY BRANCHES Lt. Jonathan Delano Branch

Continuing with our genealogical outline we will cover the Lt. Jonathan Delano Branch in this issue. Most of this information was compiled by our genealogist, Muriel C. Cushing.

Jonathan Delano b. Plymouth 1647, the fourth son and seventh child of Philippe and Hester DE LA NOYE, d. Dartmouth 28 Dec. 1720 in his 73 year.

Jonathan md. Dartmouth, 28 Feb. 1677/8, Mercy Warren, dau. of Nathaniel and Sarah (Walker) Warren and a descendant of Pilgrim Richard Warren of the Mayflower. Mercy was b. in Plymouth, 20 Feb. 1657 and d. after 6 Nov. 1727.

Jonathan Delano removed to Dartmouth from Plymouth where he was a selectman and a Lieutenant. He was one of the original proprietors of Dartmouth (now Fairhaven, MA). He served in the Indian War of 1675-6. He received his commission in 1689 from Gov. Hinckley.

Jonathan Delano's will dated 17 Dec. 1720 calls him yeoman, of Dartmouth, & names his wife Mercy; sons Jonathan, Jabez, Nathaniel, Jethro, & Thomas; & daughters Esther Delano & Mercy Hatch; grand-daughters Meribah Delano & Susanna Nye. His will was proved March 1720/1 & inventory dated 30 Jan. 1720/1.

Jonathan and Mercy had 13 children all born in Dartmouth as follows:

- 5th Mercy, b. 27 Oct. 1686; d. Tolland, CT before 16 May 1734; md. ca. 1712, Joseph Hatch.
- 6th Nathan, b. 29 Oct. 1688; d. prob before 17 Dec. 1720; md. Middleboro, 7 July 1709, Elizabeth Miller.
- 7th Bethiah, b. 29 Nov. 1690; d. 19 July 1693.

## OFFICIAL GENEALOGICAL REFERENCE Adopted by the DELANO KINDRED Board

The Genealogy, History, and Alliances of the American House of Delano 1621 to 1899 (New York, 1989) compiled by Major Joel Andrew Delano and Arranged by Mortimer Delano de Lannoy (referred to by the acronym GHAAHD) is the most comprehensive Delano family history known to officers and directors of the DELANO KINDRED. Although known to have "a large number of errors" and a somewhat "awkward manner of presentation," its 561 pages of information, which include a detailed general index, have proved to be a valuable source for determining lineage of a DELANO surnamed, descendant/ancestor born before 1895 to 1899.

The GHAAHD is arranged in two books. The first book contains a history and heraldry of the Maison de Franchimont and de Lannoy from 476 to 1621 as well as some details of the DELANO de LANNOY coat-of-arms including the motto "Bonnes Nouvelles." The second book is The DELANO Genealogy from 1621 to 1899.

Because of its comprehensive documentation, the DELANO KINDRED Board has adopted the GHAAHD as the major genealogical source for this Society, notwithstanding its errors and arrangement. One of the goals of the Society is to correct and update this reference.

There were only 400 original copies of the GHAAHD printed in 1899. However, Higginson Books, Derby Square, Salem, MA 01970, phone (508)745-7170, has good copies of the original with illustrations. The sale price of the GHAAHD is \$50.00 (US) plus postage—a savings of 30% under the catalogue price. # DOCUMENTING OUR DESCENDENCIES

One of the Society's goals is to "update and perfect" the GHAAHD. By updating the GHAAHD we hope to bring the lines forward from 1899 into the 20th century. By perfecting the GHAAHD we hope to prove the lines listed in Book Two through genealogically accepted documentation.

When one considers the pyramid effect of ten or more children in each generation per family in each of the branches created by PHILIPPE DE LA NOYE, the number of descendants increases to well over a million in the 5th generation. Muriel, with help from some of our members, has researched, compiled and documented DELANOs and is now into the fifth generation from PHILIPPE. She has encoded each of those descendants in the standard numbering system used by the Mayflower Society and many other genealogical organizations. This system should eliminate much of the confusion which occurs in the GHAAHD with generations of children with the same name—for example the multiple Thomases, Jabezes and Jonathans.

In order to move forward, Muriel will need our help in bringing our lines up to the present with documentation. To accomplish this, your Board of Directors has approved the concept of the DELANO KINDRED GENEALOGY PROJECT through which we hope to eventually achieve the Society's goal. The success of this project will depend on our members' cooperation in the collection of data.

Data collection is planned to be in two steps. The <u>first step</u> will be completion of a "preliminary" form which lists all the generations in each member's individual descendancy line from PHILIPPE DE LA NOYE. The preliminary form will aid "updating" the GHAAHD to the present. The <u>second step</u> will be the documentation of each descendant in that member's line. This step will aid in "perfecting" the GHAAHD.

Members whose completed forms are approved by our genealogist will be considered members who have documented their descent. These members will also be eligible to receive a certificate for their efforts in this project.

We should recognize that updating and perfecting the GHAAHD is an extensive project which will take considerable time. We hope to publish pamphlets and booklets when a significant number of generations have been completed in related lines within a branch. Eventually we will be able to publish an updated GHAAHD.

## THE TOWNS OF DELANO IN NORTH AMERICA Now and Then

In our previous News Letter we noted that on page 4 of the GHAAHD there was a list of DELANO towns known to have existed in Canada and the United States. We mentioned the five Delano towns that no longer existed and the fact that Delano County in South Dakota had disappeared. In that News Letter we discussed the history in naming the town of Delano, TN. In this News Letter we conclude the series on DELANO towns until more information is received.

Delano, Kern County, CA 93215-16; located about 25 miles north of Bakersfield has a population of 22,762. Delano was named for the Hon. Columbus Delano, Secretary of the Interior from 1870 to 1875 (GHAAHD pg. 311) under President Ulysses S. Grant (GHAAHD pg. 390). Delano was formed when construction work on the San Joaquin branch of the Central Pacific Railroad (later known as the Southern Pacific) connecting Stockton with Los Angeles stopped short of Bakersfield in June 1873. This halt was due in part to the panic and depression of 1873. Construction did not resume until after July 1874. During that year Delano (where the rails ended) became a boom town. Freight from the north to Los Angeles came south to Delano by rail and was then hauled by mule teams to Bakersfield where rails coming north from Los Angeles stopped. Rail passengers going south to Los Angeles paid a fare of \$7 for a stagecoach to take them from Delano to Bakersfield.

<u>Delano Park, ME</u> 04106 is located near South Portland, ME. We would appreciate knowing the history of this town. Although they are not towns, we are also aware of Delano Hill and Delano Cove, both N.W. of Friendship ME—the latter

being open to the northern reaches of Muscongus Bay.

<u>Delano, MI</u> 48703 is located NW of AuGras, MI (on the north side of Saginaw Bay) in Arenac County. Again, we would appreciate any information about the history of this town.

<u>Delano, MN</u> 55328 in Wright County (about 14 miles west of greater Minneapolis on US 12) has a population of 2,709. Formerly named Crow River, the name was changed to Delano in 1870 in honor of Francis Roatch Delano (GHAAHD, pg. 500) who was then the active and enterprising Superintendent of the St. Paul and Pacific Railroad. Besides railroading Mr. Delano built a mill, penitentiary and warden's house in Stillwater, MN. He was a lumber manufacturer, the mayor of Stillwater, and the first warden of the penitentiary. His many other accomplishments included being a representative to the state legislature.

<u>Delano, PA</u> 18220 in Schuylkill County (near exist 37 on I-81 or about 6 miles NE of Mahanoy City) has a population under 500. Delano was named after Warren Delano of New York who owned land there (pg. 4, GHAAHD) and is believed to be Warren Delano 2nd Sr, the grandfather of Franklin Delano Roosevelt (pg. 505, GHAAHD).

We were unable to find a Delano, WA in Pierce County; however, a check of U.S. Zip Codes disclosed a <u>Delano, WA</u> 99133. The 1993 Rand McNally Road Atlas does not show this town. Based on the zip code, it may be NW of Spokane, WA near Franklin D. Roosevelt Lake. Delano's population is probably less than 500. Our check of zip codes also disclosed <u>Delano Beach, WA</u> 98349. This town is also not in the Road Atlas. We believe it is located on the northern Pacific coast near LaPush, WA 98350. Again, its absence from the Road Atlas suggests its population is under 500.

Although there is no town named Delano in Utah, one of the higher mountain peaks in that state is named <u>Delano Peak</u> (elev. 12,173 ft.). It is located east of Beaver, UT (I-15 mile post 110) just north of the Elk Meadow/Mt. Holy Ski Area. It is believed to be named after the Hon. Columbus Delano.

We are also aware of a former country post office located in Virginia named Delano's Store which is located on the eastern portion of the "Northern Neck" of VA or VA route 200, north of Wicomico Church. The combination country store and garage is currently operated by George Delano who is a descendant of Capt. George Delano (pg. 251, GHAAHD) who moved south from MA and settled in VA in 1820.

## A RUSSIAN CONNECTION

This article by Joan Hartnett-Barry about one of our DELANO ancestors, James Haskell Delano (GHAAHD, pg. 436) appeared on 6 Feb 1991 in <u>THE SENTINEL</u> (presumably a Marion, MA newspaper).<sup>2</sup> It was submitted by our genealogist Muriel Cushing who visited the Sippican Historical Museum in Marion. Muriel reports that a visit to this museum is well worthwhile. It seems that Marion was originally part of Rochester and many DELANO families lived there.

"The Russian Aristocrat and the Man from Marion"

Who would think that a Marion naval officer and a Russian aristocrat would fall for each other? He did and she did and the rest is history.

Twenty-year old Marion native James Delano joined the navy at the outset of the Civil War in 1865. He saw action while aboard the USS Galena at the Second Battle of Fort Fisher. During this time away from Marion, James corresponded with his Marion sweetheart, Philura Hathaway, and sent her small gifts.

Delano was stationed aboard the USS Augusta in 1866 when it received orders to go to Russia to extend congratulations to Emperor Alexander II—"The Liberator"—on his recent escape from assassination. They arrived in Russia and were royally received and entertained. It was at one of the balls held in their honor that James met Alexandrina Petrovna Kuzmishchova. Alexandrina was closely connected by birth with the oldest aristocracy of Russia. Her father was the admiral of the Russian fleet and was the equivalent of governor of one of the largest sections of Russia. Alexandrina spoke English, French, Italian and German and could play the piano by ear. Before the USS Augusta left port in Russia, James and "Aline," as he called her had become engaged.

When James arrived at Old Landing, he was filled with stories of his adventures. Philura Hathaway sensed that something was wrong between them. James told her about his change of heart and showed her a picture of Aline which was on the back of his watch. A few days after his landing, Philura gathered up all the gifts and letters from James and put them in a wheelbarrow. She wheeled it down to his house, which was near the train tracks, and dumped the contents down the embankment.

James returned to Russia in 1867 to marry Aline and bring her back to Marion. In a notebook found after James' death were written the five things he was required to do before he could marry Aline because of her nobility and membership of the Greek Orthodox Church. His notebook read:

- 1. A certificate from the consul that I am a bachelor.
- 2. Consent of parents and witnesses' signatures.
- 3. Publishing of the banns in the Protestant Church, then Aline's, and if there is no impediment, a paper from the clergyman to show that such is the case.
- A written promise to bring up our children in the Russian religion.

5. Permission from the Emperor for her to marry a stranger.

James and Aline married in Russia and returned to Marion. Aline brought many of her personal belongings and wedding gifts to Old Landing. Her piano, linens, dishes, silver, gold coffee spoons, books, music, pictures, clothes and jewelry came with her when she left Russia. Her trousseau was complete with linen and lace made by nuns in a convent and by peasants on her father's estate. Silk, muslin, and wool dresses were sent in elaborate travel trunks. One of the trunks, along with its huge iron key, can be seen in the Sippican Historical Museum.

Aline was used to being waited on by servants, and it must have been difficult for her to do without this luxury.

Two rooms in his parents' house were allotted to the couple so they could arrange her personal items. She had four large square pillows covered with red satin. Fine linen pillowcases embroidered with the family crest covered the red pillows on the bed in the room.

The couple had a son, Alex. His grandparents and relatives took care of him when Aline traveled back to Russia every other summer. Her sister lived in a villa in Sorrento, and Aline would visit her occasionally.

After James retired from the navy, he moved his family to Boston and started a business but had no luck and Aline's money was used several times to meet his expenses. She had money and occasionally inherited more from relatives.

She became involved in Boston social life and was the secretary of Registrar of Deeds Joseph Willard. She translated books from Russian and French and gave lectures on literary and political subjects relating to Russia. She was admired by many and never complained about the life she had chosen.

When James died, she had his body brought to Marion for interment in the Delano plat at the Old Landing cemetery. She followed an old Russian custom and walked alone behind the hearse on the way to the cemetery.

Aline lived in Marion until her son moved to California. At the age of 77, she moved with him to Los Angeles, returning each summer to Marion. She died at the age of 82. In her will, she directed that her money should go to the Marion Library for the purchase of books on "history and kindred subjects."

Her obituary read, "She was a discriminating reader of serious books in all languages and liked to discuss them. She stuck vigorously to her own opinions, independently formed, but was even tempered and considerate of others, though she might and often did disagree. She was the very best of company. The world is poorer by her departure.
