2009 Annual Meeting and Reunion in Williamsburg VA

Our 2009 Annual Meeting and Reunion will be held in Williamsburg, Virginia, on Friday 19 June and Saturday 20 June 2009 at the Crowne Plaza Williamsburg at Fort Magruder. Located at 6945 Pocahontas Trail (U.S 60), the Crowne Plaza is within three miles of Colonial Williamsburg, Busch Gardens Europe, and Water Country USA. Situated on the site of a Civil War Fort, the venue is an excellent location for young and old to visit the many historic sights of Colonial Virginia. Historic Yorktown, with the Yorktown Victory Center, a museum about the American Revolution, is located several miles to north. To the south is Historic Jamestown, settled in 1607. Nearby this historic site

is the Jamestown Settlement that includes a to-scale replica of the Jamestown fort and a pier with replicas of the three ships that carried the Jamestown Colonist from England to the "New World." Along the James River are several



river plantations that can be easily visited.

Getting there:

By car: Williamsburg is located near I-64. To get to the Crowne Plaza Hotel take exit 242A to Route 199. Drive 1.5 miles and take the exit for Route 60. At the stop sign, turn left on 60 West. The hotel is one mile on left. By air: The closest airport is the Williamsburg/Newport News Airport (PDF) and is served by U.S. Air, Air Tran, Delta and United Airlines. It is located about 15 miles south of the hotel. Airport van service to the hotel is available.

<u>By rail:</u> Williamsburg is served by Amtrak. There are two trains a-day (one day and one overnight) service from Boston and other east coast corridor points. Overnight rail service is available from Florida, and from Chicago and other Mid-west points. Arrangements can be made with the hotel for transport from the train station to the hotel.



Reunion Advance Registration and Reservations:

To adequately plan and support the meals and other reunion events, we must have advance notice of those who plan to participate in each event. Registration and Reservations should be made by **10 June 2009**.

Accommodations:

We have blocked 15 guestrooms for Friday night 19 June, and Saturday night 20 June, at a rate of \$119.00 plus 10% tax plus \$2.00 or about \$134.00 per night. This rate is \$25.00 less than the rate we obtained for the 2008 Maine Reunion; however please note this rate is only available if you stay two nights since the rooms are blocked over part of a weekend. We have also blocked five guestrooms for early arrivals on Thursday 18 June at the same rate. There will be an extra charge for additional adults in these rooms. Individual guestroom reservations must be made prior to Thursday 28 May, 2009 to secure these rates. We understand that we can expand the number of blocked rooms at the above rate provided we have notice well in advance of 28 May, 2009. We strongly suggest you call at your earliest convenience to assure obtaining a room at the blocked rate. Please call the Crowne Plaza Williamsburg at Fort Magruder at the toll free number (800) 227-6963 or (757) 220-2250. All guests should identify themselves as members of the DELANO KINDRED Family Reunion Group. You will receive a confirmation number for your

room reservation. Room reservations can be cancelled without penalty if the notice of cancellation is received $\underline{72}$ <u>hours in advance.</u> In the event you reduce the number of nights of your stay at the hotel after you check in there will be a \$50.00 early departure fee unless you notify the hotel 24 hours in advance of your departure.

Reunion Registration:

Registration will be held near the Room assigned for the Friday Welcome Light Buffet from 4:00 PM to 6:00 PM. Registrants will receive a "Welcome Envelope" containing Reunion information and nametags. Late registration will be held from 8:30 AM to 9:00 AM Saturday in the room assigned for the Annual Meeting.

Events:

Because there has not been enough time available for genealogical consultations at past reunions, we have scheduled additional time this year for a **Genealogical and Informational Symposium** for those interested on Friday morning, 19 June from 9:00 AM to 11:00 AM.

The Friday night **Welcome Light Buffet Dinner**, will be held in the Generals Redoubt Room at 6:00 PM. The Buffet will be served at 7:00 PM with a cash bar available starting at 6:00 PM. It will be a night of fellowship and pleasantries where one can meet and greet new members as well as visit with old acquaintances. Genealogical consultations will also be available. Other events may also be scheduled that evening. The buffet menu will include: Assorted Sliced Deli Meats, Assorted Sliced Cheeses, Salads, Assorted Vegetables, Breads and Rolls, Desert and Beverage.

On Saturday at 9:00 AM, the **2009 Annual Membership Meeting** will be held in the same or nearby room. We plan to have the minutes and the committee reports available in advance at registration to reduce the overall time of the Annual Meeting as we did last year. ANCESTRY AND HISTORY OF PHILIP DELANO BORN PHILIPPE DE LANNOY by George English (continued)

In the last issue we started a review of Cousin **George English's** article which appeared in two parts in the *Mayflower Descendant*—Vol. 56 No. 1 and Vol. 56 No. 2. Because of the length of the article in Vol. 56 No. 1, we divided up the review of that portion into two sections—the first section, appearing in the last issue, reviewed eighteen publications that studied the de Lanoy (de Lannoy) family. We consider that the most

important publications besides the GHAAHD (the first attempted detailed study of the family) were:

- B. N. Leverland's article "The Family of Jan de Lannoy" which provides documentation that corrects GHAAHD and Chapter one of *Franklin Roosevelt and the Delano Influence*.¹
- The 21 November 1963 letter from Miss A.
 J. Versprille, Chief Archivist of the Leiden City Records which confirms the information found by M. Boeke that Guilbert de Lannoy's family came from Canterbury and joined the Leiden Walloon Church in 1591.²
- Col. Albert de Lannoy's comprehensive and reliable work in the OGHB's (Office Généalogique et Héraldique de Belgique) *Le Parchemin* titled "Answer to question 2301". In it he cites all the known de Lannoy baptisms, marriages/betrothals, and may likely be the first person to publish information that Guilbert de Lannoy's family came to Leiden from Canterbury, that Guilbert likely had a son named Pierre, and that Guilbert's wife's maiden name was Jeanne du Bus.³
- Dr. Jeremy Bangs' article entitled "The Pilgrims and other English in Leiden" which provides documentation by Leverland plus some additional data and some documentation concerning the Mahieu family showing the relationship between Francis Cooke's wife, Hester, and her sister, Marie (Mahieu) de Lanoy, who was Philippe de Lanoy's mother.⁴

The remaining portion of part one of Cousin George's article is devoted to the de Lanoy

family in Leiden from their arrival in 1591 to 1621. The article notes that it is mainly the various Leiden and Walloon Church Records that provide, so far, most of the information we have about the de Lanoy family. After a summary of the tribulations suffered in Leiden as a result of two Spanish sieges, the subsequent declaration of independence by the United Provinces of the northern Spanish Netherlands in 1581, and the establishment of the Leiden Walloon congregation in the medieval church named the Vrouwekerk (in 1584), there follows a discussion of documents that show the relationship of the de Lanoy, the Mahieu and the du Bus families. The discussion supports the genealogical description of the de Lanoy family starting with Guilbert and Sjan (Jeanne) de Lanoy shown at the end this article.

- The information cited in the Versprille letter and found in the Archives of the Walloon Church of Leiden, Actes du Consistoire [1584-1611] shows that, by deposition (letter of transfer) from the Walloon Church at Canterbury, Guilbert de Lanoy, his wife and daughter Marguerite joined the Leiden Walloon Church on 29 March (Easter) 1591. So we know that Guilbert had a daughter named Marguerite and his family came to Leiden from Canterbury, England.
- On 21 July 1592 banns were published of the betrothal of Marguerite de Lannoy with Oliphier de Plaes, from Mouvau (Mouvaux north of Lille) who was accompanied by his brother, Jakes de Pales, and a friend, Corneille du Pla. Marguerite was accompanied by her mother, Sjan (Jeanne) de Lanoy, and her sister, Nowe (Noelle). So we now have the name of another daughter of Guilbert ⁵
- On 13 January 1596 the banns of Jean de Lanoy and Marie Mahieu were published⁶. We have seen this betrothal referenced many times by Leverland, Bangs and others. A photocopy of

the document as shown in the Church Betrothal Register is included by the author below.



Translation: Jan Lano, young man of Tourcoing, accompanied by Pierre du Bu and Gijsbert Lano, father of bridegroom with Marie Mahieu, accompanied by her mother Jeanne Mahieu and Anthonette Morth, her acquaintance. It is speculated that Jean de Lanoy may have met Marie Mahieu when both families were in Canterbury.

- On 13 February 1599 Pierre de Lannoy was betrothed to Catherine Famineel of Nivelles (in Brabant—now a region of Belgium).⁷ Pierre had previously joined the Leiden Walloon church that month and was said to be from Poperinghe-a town about twenty miles westnorthwest of Tourcoing. Witnesses were Pierre du Bu, his uncle, and Oliver de Plaes, Pierre's brother-in-law. This entry shows that it is likely that Pierre de Lannoy was a son of Guilbert de Lannoy and, as Col. Albert de Lannoy notes, from this entry "one can conclude almost with certainty that the wife of Guillebert de Lannoy was called Jeanne du Bu, or better, du Bus, a family of Lille and the region"⁸
- Page 48, the GHAAHD states that Esaie (Isaiah), the first child of Jean and Marie (Mahieu) de Lanoy, was baptized in "the church of Tournai Hanau [Belgium]"⁹. The Archives in Tournai have said that "Hanau means the province of Hainault". This may likely be confused with the city of Hanau in Germany. It seems very unlikely that Jean and Marie de Lanoy would have ventured to Tournai when it

was in control of the forces of the Duke of Parma and under Spanish rule. Hanau is a city in Germany and it turns out that Count Philip Ludwig of Hanau had allowed Walloon refugees to settle near Hanau. E-mail correspondence by Cousin George to the State Archives in Hanau, Hesse, Germany, determined that in fact there was a child named Isaiah born to a Jean and Marie de Lannoy in Hanau. A later baptism in 1601 of a child of the same parents suggests that there are likely two Jean and Marie de Lanoys. There is no record of Jean and Marie de Lanoy of Leiden traveling to Hanau, Hess in their early years of marriage - before their daughter Jenne de Lanoy was baptized in Leiden on 16 March 1601. At this point is seems unlikely that parents of Isaiah (baptized in Hanau) are the same Jean and Marie de Lanoy who were parents of Philippe de Lanoy (baptized in Leiden).

- On 18 March 1601 Jenne de Lanoy, the first recorded child of Jean and Marie de Lanoy was baptized in Leiden¹⁰. Witnesses were Pierre du Bu (who was probably brother-in-law of Guilbert de Lanoy-- Jean's father), Ollie le Pla (Oliver le Plaes, the brother-in-law of Jean de Lanoy and his sister Marguerite's husband), Jenne le Mahieu (who is either Marie de Lanoy's mother or her sister who is also named Jenne).
- On 6 November 1603, Philippe de Lanoy, Jean and Marie's second child was born in Leiden¹¹. Witnesses were Francois Kock (or Coek) (brother-in-law and husband of Hester Mahieu), Philippe Marines, Tonnette de Lannoy and Marguerite de Lannoy. Cousin George suggests that it is probable that Tonnette (Antoinette) de Lannoy was another sister of Jean de Lanoy because she was a witness at Philippe's baptism. This seems a likely conclusion, but no documentation has yet been found to support this.
- Olivier de Plaes had died, because on 27 February 1604, Jan de Rousseau, a woolcomber from Moevaux, and a widower of Jannetgen Salmon, accompanied by Sacharias Millecan, his

cousin, and Joris le Schrijver, his brother-in-law, was betrothed with Margariete Lanoo, from Tourquoyn [Tourcoing], widow of Olivier le Pla. She was accompanied by Cathelyne Marlière, her aunt, and Marie de Lanno, her sister-in-law. Moevaux is a town just north of Lille and the same town Olivier de Plaes was from. The presence of Marguerite's, aunt Cathelyne Marlière, is interesting since it indicates that she may be a sister of Guilbert de Lanoy.

- Jean de Lanoy died, because on 18 February 1605, the betrothal of Robert Mannoo, woolcomber from Namen [Namur, a city now in south Belgium], widower of Symone Pachette, accompanied by Jan de Seurne and Guillaume van Dale, his acquaintances, is recorded with: Mary Mahieu, from Rijssel [*Lille*], widow of Jan de Lanno, accompanied with Jenne Mahieu, her mother, and Anthonette Mahieu, her sister¹². So Philippe probably had little or no recollection of his father Jean de Lanoy. No records of any children of Robert Mannoo and Marie (Mahieu) de Lanoy have been found.
- Two further marriages are cited that appear to involve younger sisters of Jean:
 - On 16 Sept. 1611 Mary [Marie] de Lano of Canterbury of England, accompanied by Pierron de Lano, her maternal aunt, and Franchoyse du Buy, her acquaintance, to Marcus Dusaert [du Saert] of le Celles [Celles] in Henegouwen [Hainault], widower.of Anna du Can, accompanied by Guilliam Norreth, his master, and Charles Tybault, his cousin. They were married in the Walloon Church¹³
 - On 17 Oct. 1614 Jenne [*Jeanne*] de Lano of Canterbury in England, accompanied by Cathelijna Dubuy her maternal aunt and Margriete Lano her sister, to Jan [*Jean*] de Soetere of Wormshout [*Warmhoudt*] in Flanders, [who was a] wool-comber, accompanied by Matheus Campioen and Marcus Dusere.¹⁴

George English notes that Mary de Lano is probably a sister or a close relative of Jean de Lanoy, that it is possible that Pierron de Lano is a sister of Guilbert de Lanoy¹⁵, and that Jenne de Lano is a sister of Jean de Lanoy.¹⁶ Cousin George English then concludes that information from the Leiden Registers confirms and adds to the GHAAHD, with the following amendments.

- "Betrothal of Jean de Lannoy and Marie Mahieu

 Delano Gen., 48, correctly records this as 13
 Jan. 1596, but gives the place as Tournai (in the province of Hainault) instead of Leiden. This is almost certainly a transcription error."¹⁷
- The Tourcoing origin of Jean and his sister Marguerite, is confirmed by their Leiden betrothals. Delano Gen. states that Guilbert "was born at Tourcoing in 1545" and his son Jean "was born about 1570". On page 51, four possible sources of this information are given -Rammelman Elsevier, Leiden Archivist in 1879; Gerlings of Leiden Bankers H. F. G. Association; and two Delanos, John and Edward. The Leiden Archives appear to be the most likely source but no current record has been found there to confirm this. The birth years appear to be reasonable deductions, taking 25 years from the date of Jean's betrothal for his birth; and then 25 more years for the birth of his father in 1545 (one author has 1535 but no information is provided to support this)."¹⁸ It should be noted that this amendment was written

before Dr. Jeremy Bangs had visited the Lille Archives and found the baptismal record of Jean de Lanoy who was born in the Church of St Christophe at Tourcoing on 9 May 1575 (as reported in *Bonnes Nouvelles* #55 July-August 2007). Therefore, that Jean de Lanoy was born in 1570 as stated in the GHAAHD is incorrect and the statement in the GHAAHD that Guilbert de Lanoy was born in Tourcoing in 1545 is an estimate with no documentation identified to support it. Following this rationale with the new baptismal information would make Guilbert's birth date, in some locale and not necessarily Tourcoing, as 1550.

- Delano Gen., 62 mentions Abraham de Lannoy as being the first of the Holland house of Lannoy in New Amsterdam [New York]. Evidence has now been found that he was baptized in Haarlem, Holland in 1616, the youngest son of Jean de Lannoy [Jan de la Noij], born 1575/76 in Wervik, Flanders (5 miles north-west of Tourcoing and now divided in two by the border formed between France and the Low Countries in 1668). Jean was the son of Jerome [Jeroen] de la Noij.¹⁹Abraham went to New Amsterdam in 1651 or 1652 and his son Peter, baptized in Haarlem in 1649, was to become the first elected mayor of New York in 1689. The Delano DNA Project has now shown that there is a 99% likelihood that Abraham and Philippe de Lannoy have a common ancestor.²⁰ Cousin George concludes the most recent possibility for this person would be someone born around 1520, who was the father of both Guilbert and Jerome de Lannoy. Of course, it could be earlier than that.
- "Mr. Boeke of the Walloon Library in Leiden was the first to record, in 1963, that the de Lannoys had been to England "around 1570" before going to Leiden. A letter from the then archivist of Leiden, Miss Versprille, presumed to have been the work of Leverland, also confirmed this calculation."²¹ It should be noted

that this calculation would have to be reevaluated in light of the discovery of Jean de Lanoy's baptism date.

On page 88, Cousin George English provides this very helpful map of the Flanders and Hainault area with the relative location of the cities/towns mentioned in his article as shown below. The map shows the modern border between France and Belgium which did not exist when the de Lanoys and Mahieus lived there. Tourcoing and Lille were not in France, but were part of the Spanish Netherlands. The border was formed after French Flanders became part of France in 1668 and Belgium became an independent country in 1830.



He then provides the following genealogical summary.

Genealogical Summary of Guilbert de Lannoy's family

GUILBERT^B DE LANNOY was probably born in Tourcoing, Flanders, circa 1545. Guilbert married **JEANNE DU BUS**.

They fled to England, possibly via Poperinghe, with their family probably in the 1570s. They came from Canterbury to Leiden at Easter 1591.

Children of Guilbert and Jeanne (du Bus) de Lannoy:

i. MARGUERITE DE LANNOY, b. Tourcoing, Flanders; m.(1) OLIVIER DE PLAES

in Leiden, Holland, *ca*. Aug. 1592; Olivier b. Mouvaux, Flanders, d. prob. Leiden, Holland, before. 27 Feb. 1604; m.(2) JEAN DE ROUSSEAU in Leiden, Holland, 14 Mar. 1604;Jean b. Mouvaux, Flanders.

Franklin Delano Roosevelt Tennessee Valley Authority Monument

Dedicated in Sheffield, Alabama

An alert reader, Lynn Delano Fritts, mentioned the celebration of the 75th year of the creation of the Tennessee Valley Authority in 1933. On Thursday 22 May over 200 people gathered to witness the dedication of the Franklin Delano Roosevelt monument containing 3 large bronze plaques: one of FDR, one telling the story of his visit to

Sheffield, Alabama in 1933 and one plaque listing the names of contributors to the monument's construction. The Sheffield City Historian, Richard Sheridan, told those in attendance of FDR's Sheffield visit by rail car in 1933 following Congress' signing the declaration bill creating the Tennessee Valley Authority. As you may recall it was the Tennessee Valley Authority that brought electric power to northern Alabama and Tennessee. This FDR monument is the only monument erected in FDR's memory near the Tennessee River.

Lynn D. Fritts said, "FDR's New Deal provided for the development of the Tennessee Valley Authority which has been a tremendous asset to our area. I, as a DeLano by birth, work near many of the plants owned by TVA. This memorial was constructed in Sheffield, Alabama on the very corner where FDR gave his speech." Dorothy Delano Ferguson

The DeLano Homestead Cooper Center, Michigan Celebrates its 150th Anniversary

Those of you who attended the 1995 Reunion in Kalamazoo, Michigan will recall the visit to the restored home of William Smith DeLano (1819-1901). At the age of 19 William came to Michigan with his Aunt Lydia and Uncle Ichabod Hart with whom he lived until he was 21 years old. After working, by the month, for various farmers in Cooper, he was able to purchase 40 acres of land to start his own farm. In 1844 he built a log cabin on his property and continued to add acreage to his farm. In 1858, he built the house which stands today. Over the years his farm grew to 258 acres and included a silo, several barns and other outbuildings. The DeLano family lived in the home until 1963. In 1968, the Kalamazoo Nature Center purchased the property and by 1976 the house was restored to its original condition, thanks to the generosity of many descendants, friends and supporters.

During each year many activities for young and old are held in the house and on the Homestead land. In September, the Nature Center hosted a celebration of the house's 150th anniversary. A special invitation was extended to William S. DeLano's descendants. Cousin **Joan G. Colgren** reported that five of William DeLano's great-grandchildren were at this celebration. Besides Cousin Joan they included Cousins **Martha D. Davis, Suzanne D. Parish, Bernard D. Campbell** and **George D. Gerpheide.**

At the celebration Cousin Martha Davis remarked how she had grown up on part of the Her grandfather, Fred Smith Homestead land. DeLano had purchased farm land from his father William S. DeLano. This land was passed to her father. She told of attending a one-room school known as the DeLano School because William S. DeLano donated the land for it and he and his sons planted trees along the south side of the lot. The Homestead was inherited by William DeLano's youngest son Orlyn and his wife Myrtice. Orlyn farmed the acreage for many years and he and Myrtice lived in the old house. She recalled what a treat it was to visit "Uncle" Orlyn and "Aunt" Myrtice. Orlyn was one of the dearest people she had ever known and Aunt Myrtice was famous for her molasses cookies. Many of the great grandchildren recall visiting the farm to see the new baby lambs and to pick spring wild flowers in the glen on the farm.

The DeLano Homestead has been an important part of the Kalamazoo Nature Center educational programs ever since. Each year thousands of school children visit the DeLano Homestead to learn how the early pioneers relied on nature to help them survive and thrive in the mid-19th century. Future plans include expanding the role of the DeLano Homestead by turning it into a sustainable working farm. School children and others would be able to work alongside the farmer to care for animals and cultivate the crops. This will add a new dimension to the DeLano Homestead experience and one which will give many children a taste of farm life in the late 1800's.
